The principal components used in this product have been reacted and are tightly bond in a polymeric matrix that has a negligible vapor pressure so there is a low potential for inhalation or ingestion of ingredients. The finished polymerized product is an inert rubber, and exposure to the original constituents would not be expected under normal conditions. Like most high-molecular weight polymers, this product is not known to exhibit any adverse acute or chronic health effects. Burning this material or exposing it to temperatures in excess can generate irritating and toxic fumes. The type of compounds generated depends upon temperature and conditions. Processing, e.g. by grinding, sanding, sawing or cutting this product may generate dust or particles. Dust or particles may have dangerous health properties.
