### 3.1 Mixture of Substances

Proprietary mixture of synthetic waxes, resin(s), and additive(s) with a non-hazardous water-based adhesive coating. No components need to be disclosed according to the applicable regulations.

## Section 4 First Aid Measures

### 4.1 Description of first aid measures

**Inhalation** Get medical assistance if irritation develops or persists. If breathing is difficult, move the person to fresh air. Give artificial respiration if person is not breathing.

**Skin contact** For thermal burns, flush or submerge affected area in cold water to dissipate heat. Cover with clean bandage material. Do not peel material from skin. Get medical attention. For contact at ambient temperatures, wash with soap and water.

### Section 6 Accidental Release Measures

#### 6.1 Personal precautions, protective equipment and emergency procedures

##### Appropriate engineering controls
