Store at ambient temperatures in closed containers. Chemical incompatibilities: Strong acids, strong bases, water, humidity. Corrosive substances in contact with aluminum may produce flammable hydrogen gas.

With product at ambient temperatures, use disposable nitrile, neoprene or butyl rubber gloves with repeated or prolonged use.

The need for respiratory protection is not anticipated under normal use conditions and with adequate ventilation.
